REGIONAL SUMMARY:

(Provide a summary of the council including regional background/demographic and other information unique to individual region/county)

The Montgomery County Regional EMS Council was organized in 1988, after the original Southeast PA EMS Council was dissolved to give each of the five counties a more direct role in providing EMS programs for their residents and visitors. It was very important to ensure that policies for providing EMS services, training and equipping personnel were tailored to each county's specific dynamic needs.

Montgomery County is 483 square miles, and it contains urbanized centers such as Norristown & Pottstown, large suburban communities to the east and extensive tracts of farms and woodlands to the west. With a population of over 845,000, Montgomery County has a higher population than four individual states. It contains a complex array of highways including many miles of the Pennsylvania Turnpike, the largest shopping mall in America, a national park, a casino, and the Limerick (Nuclear) Generating station. There are also eight acute care hospitals, including two trauma centers.

Montgomery County EMS works very closely with our partners in adjoining counties and have cooperated for decades on civil defense and emergency management issues. More recently since the tragedies in 2001, the five county EMS offices have worked closely with the Southeastern Pennsylvania Task Force on regional planning, preparedness and EMS issues.

Our professional staff ensure that all EMS personnel, agencies and ambulances are adequately equipped and prepared to provide the best out-of-hospital emergency care possible. We are responsible for inspecting ambulances, providing education and technical assistance, and administering certification exams. We also conduct investigations, provide clinical expertise with our Medical Advisory Committee (MAC) and coordinate with our hospitals to ensure quality care. We work closely with our elected municipal officials to conduct planning and coordination to improve our EMS system, including special events planning and emergency operation center activations during natural and man-made disasters. Clinical excellence is fostered by the Montgomery County Medical Advisory Committee (MAC). Other programs established to strengthen our capabilities include careful coordination and training with 9-1-1 telecommunicators, emergency managers, hospitals and public health. Our in-county emergency assets include a Medical Surge Equipment Cache (MSEC), a Casualty Collection Point (CCP) trailers and multiple resources to respond to mass-casualty incidents.

Regional Activities/ Organizational Management Project Narrative:

Montgomery County operates the PulsePoint alerting app for CPR calls, this system directly alerts citizen first responders. The registered CPR ready persons who have signed up for phone alerts will be activated if they are within one quarter mile of someone needing CPR. There is also a crowd sourcing app titled Automated External Defibrillator (AED) registry that enables citizens to register AED sites, they are validated by the EMS staff and the CPR needed responders are notified where the nearest AED is located in an emergency. There were 51 businesses that added 108 AEDs and all these were added to the PulsePoint database. There are over 8,000 registered users in PulsePoint and nearly 5,000 are logged into the CPR Alert for citizen responders.

Nearly all public education events were suspended this fiscal year. See regional activities.

CPR training continued third-party independent instructors-Regional EMS Office represents an American Heart Association Training site and issues credentials to students who complete training. 228 courses with 1,239 e-cards issued.

MCEMS continues its work with EMS Agencies and municipal leaders to ensure that response areas are properly defined and aligned for rapid response and to maximize patient care. Staff worked with ambulance agencies, municipalities, and the 9-1-1 Emergency Communications center to revise and refine emergency response zones across the county in various municipalities.

Many of the elected official inquiries come from our municipalities as they continue to work to monitor and improve EMS system coverage in their corresponding areas.

A pilot program to evaluate Ketamine for Sedation Assisted Intubation (KSAI) was completed with report to the Bureau and the protocol will be included in the 2021 State Treatment Protocol manual.

Two hospital systems inspections for re-accreditation were deferred and will be completed in the next fiscal year cycle.

Pilot program providing field antibiotics by EMS for open fractures was instituted in October, 2020

Hospital divert status is tracked using VEOCI software to report hospital diversion for transporting ambulances.

Systems Operations Narrative:

There are three accredited EMS Training Institutes (2-BLS and 1-BLS & ALS) that conduct training programs from multiple locations. During this fiscal year the sites were visited for initial inspections after receipt of a completed application.

Staff assisted, Delaware County EHS Council with a large agency inspection at Keystone Quality Ambulance Agency using COVID precautions. Multiple staff from MCEMS assisted in the all-day process.

Priority One ONLY policy implemented for QRS Agencies that requested a change in their agency dispatch policy. Two agencies have made the requested change.

The Montgomery County Department of Public Safety-EMS has been licensed at the Advanced Life Support Squad level by the Pennsylvania Department of Health. An independent inspection of the ALS Squad requirements was conducted by the Bucks County EHS office staff.

Licensure inspections were halted at the direction of the Bureau for COVID19 safety concerns. MCEMS is restarting inspections at the direction of the Bureau following all safety guidelines.

Emergency Preparedness Narrative:

MCEMS is very active in regional planning and coordination for emergency preparedness. Planning and participation with groups including, Health Care Coalition and monthly Hospital Zone meetings (By County), Southeastern PA Task Force, Task Force Emergency Response Workgroup and EMS Committee.

MCEMS staff have served on the SEPA SMART-SMAT Governance Group as well as involved in the SEPA SMART-SMAT reformation in accordance with the Task Force Board orders.

Montgomery County EMS works side by side with Public Safety peers including Emergency Management and Montgomery County Office of Public Health.

MCEMS staff serves as the chair of the SEPA Task Force EMS Committee and also serves as a member of the Emergency Response Work Group (ERWG). There were plans for a Full Scale Exercise (FSE) to be conducted and it has been deferred until the Summer of 2022.

MCEMS staff coordinated with the EMS EP staff, the change out of equipment, received six powered Air Purifying Respirators (PAPR) and other Personal Protective Equipment (PPE) for emergency response. MCEMS adopted twenty-seven (PAPRs) from the SEPA SMART cache

MCEMS continues to support three Strike Team EMS Agencies as well as Emergency Response assets including: Medical Surge Equipment Cache and a Casualty Collection Point mobile trailers.

MCEMS maintains five mass casualty care asset caches using SEPA Task Force resources.

MCEMS staff along with Public Safety staff collected requests, coordinated supplies and delivery of numerous shipments of Personal Protective Equipment (PPE) supplies for EMS Agencies. These were received, stored, and delivered using County Public Safety warehouse personnel, and transportation assets, and included MCEMS staff.

MCEMS assisted in deploying EMS treatment trailer and supplies for a special event in June of 2021 in Pottstown Borough.

- MCEMS staff participates in all Montgomery County Ambulance Association meetings and activities to work closely together on mutually beneficial projects and improve the EMS System.

- MCEMS and the Montgomery County Ambulance Association continue to work together to address a critical personnel shortage. The Ambulance Association continues to operate a recruitment web page and applicants can file a collective job application accessible to all EMS Agencies participating.
- MCEMS continues to participate in several Overdose Program initiatives:
- As the Pennsylvania Commission on Crime and Delinquency (PCCD) grant Central Coordinating Entity, we have distributed hundreds of doses to all approved entities.
- MCEMS collects and processes all Naloxone use data by police, EMS and other authorized agencies

EMS staff worked in various positions for multiple hours in the following areas of the emergency operation center: logistics, EMS operations, communications, Alternate Care Sites Coordination, testing centers, mass vaccination clinics, mobile vaccination clinics, special circumstance clinics, and homebound vaccination clinics.

MCEMS Training staff operated under our continuity of operations plan and noncritical staff were assigned to work virtually from their homes

EMS staff assisted with planning, logistics and implementation of the first COVID vaccines to EMS providers in SEPA with a Moderna clinic held at the Montgomery County Public Safety Campus on December 28, 2020.

Since that first clinic the MCEMS staff and newly created Mobile Integrated Health County staff along with the Chief Medical Officer and team has completed nearly 9,000 vaccines to priority groups.

EMS staff coordinated licensed ambulance standbys at multiple mass vaccination clinic sites

Participated with input in the After-Action Review covering the response by the Montgomery County Department of Public Safety to the COVID 19 Pandemic. Part I covered the time from outbreak (March 7) through testing covering about 6 months. Part II awaiting publication covered the pandemic from vaccines available until current time at the end of the fiscal year.

MCEMS staff trained two telecommunicator classes in the APCO Emergency Medical Dispatch protocols to be used for 9-1-1 emergencies utilizing dispatch and emergency telephone instructions.

EMS Training and Certification activities continued training throughout the COVID 19 pandemic by moving the entire training program to an online hybrid platform.

EMS staff coordinated and assisted in the distribution of information to our EMS Agencies on grant opportunities from both County, state and federal sources.

EMS worked with County Public Safety and County Administration to apply for and receive CARES grant funding for EMS projects, including the following, PPE, High Fidelity training manikins, emergency ambulance with upfit for highly infectious disease situations, video laryngoscopes and other projects still pending.
